District 12 Director's Report

I have now completed my first year as your director and what a blast. I have attended several section meetings, national board meetings, committee meetings and district council meetings. I have gotten to meet a lot of ASCE members.

The national ASCE convention wrapped up a couple of weeks go. Held in conjunction with the convention was our fall ASCE Board meeting. Here are the results of that board meeting.

The Board approved amendments to our Bylaws and Rules as well as the regional map regarding our new governance structure, which the members approved by a wide margin in the election this past August. The sections and branches in the Pacific Northwest will become a part of Region 8. There will be no change in section or branch boundaries. Our region will consist of those sections and branches in the states of: Alaska, Arizona, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, and Washington. A regional formation team has been created, and it consists of myself and the other current director from the Region 8 area, as well as five representatives. We will begin putting together the Region's bylaws. We hope to have a draft to the District Councils by February.

The Board approved a number of federal and state legislative priorities for 2005. At the federal level our priorities are: Clean water, drinking water, wastewater issues, math and science education, natural hazards mitigation and infrastructure security, qualifications based selection for engineering services, reauthorization of TEA 21, and smart growth/sustainable development. At the state level our priority issues are: building codes, infrastructure financing, licensing, procurement of professional services, smart growth, taxation of professional services, tort reform, and transportation infrastructure financing.

The Board received a report on the requirement of faculty licensure and charged the Society's leadership with creating a task force to develop a policy on the examination of faculty for licensure. The Board declared its opposition to a recommendation that such policy waive or relax the FE experience or PE examination licensure requirements for those with doctoral degrees.

The Board received a report from the Task Committee on Section Option for total Dues. The Board voted to amend the percentage of national dues income for Section allotments from "up to 3.5% to "up to 7%. The national Program and Finance Committees will be looking for ways to implement this direction and return more money back to the sections. This decision was based on the study conducted that showed members felt they received considerably more value from their section programs than they did from national programs.

Report from the Columbia Section Structural Technical Group

Columbia Section Structural Technical Group chairman, Indra Ghosh, attended a two-day meeting at Omni Royal Orleans Hotel, New Orleans, LA on November 12 and 13, 2004. Thirty-three chairpersons or designees representing structural Technical Groups of ASCE/Structural Engineering Institute (SEI) from various ASCE Sections and Branches attended this meeting on Nov. 12. All these 33 representatives made short presentations on their local activities such as seminars, meetings, etc. Mission of SEI is to advance the profession of structural engineering by enhancing and sharing knowledge, supporting research and improving business and professional practices. At present SEI has 21,000 members in 30 countries. SEI has e-newsletter, organizes webinars, and yearly Structures Congress. In 2005 Structures Congress will be held in New York Hilton and Towers, New York, April 20-24. Details of SEI activities are available at: www.seinstitute.org.

On Saturday Nov. 13 the Professional Activities Committee of SEI of ASCE held a summit with a workshop on Separate SE Licensing Strategy. It was attended by more than 40 structural engineers. The first summit was held 4 years ago in June, 2000. This was the second summit. Various strategies were presented such as single-tier and two-tier licensing. It was recognized that although there were not too many building failures in the world, a better structural engineering practice could be exercised by a licensing jurisdiction. Licensure administration standardized through SEI, Council of American Structural Engineers (CASE) and National Council of Structural Engineers Association (NCSEA) would be one way to go.
