Myra Road Extension Project

Finding an alternate route between SR 125 and US 12 to relieve congestion, serve as a truck bypass route, and facilitate commercial growth in the Walla Walla/College Place urban area has been the focus of numerous transportation studies dating back to the late 1980s and early 1990s. The Myra Road Extension Project meets this need by establishing a new route between the two highways while providing a new access point to the adjacent communities.

The 1994 SR 125 Transportation Study evaluated alternative alignments and improvements to provide an alternate road connecting US 12 and SR 125 to improve the movement of SR 125 traffic through or around the Walla Walla/College Place urban area. This study determined that extending Myra Road from Rose Street to SR 12 provided the "Best Alternative".

The 2003 Myra Road Extension Study reviewed fourteen (14) alternate routes for implementing the "Best Alternative" for the extension of Myra Road. As a result of this study, a preferred corridor for the Myra Road Extension was selected by the Partnering Agencies, consisting of Walla Walla County, the City of Walla Walla, and the City of College Place with extensive input from the public and other stakeholders. The preferred route corridor underwent further study, public involvement and design in 2005, including the development and comparison of two conceptual alignments within the corridor. The Partnering Agencies selected the alignment shown on the enclosed exhibit for the extension of Myra Road.

The project includes the design and construction of a new four (4) lane arterial street section with a center median; separated pedestrian and bikeway facilities; two signalized intersections; a bridge crossing of Mill Creek; roadside stormwater swales; landscaping; and other features from Spitzenburg Avenue northerly to a connection with US 12 at its' planned future location, including minor widening of the existing street section from Spitzenburg southerly to the C St/ Poplar intersection.

A majority of the right of way has been acquired and the contract plans, specifications, and estimate are being prepared for advertisement later this year, with construction anticipated to begin in the Spring of 2007.
