

SCIENCE FAIRS PROJECTS REVIEWED, WINNERS SELECTED

As we have diligently done for 23 years, our Section's judges made the trip to the Greater Philadelphia Expo Center in Oaks to review student projects entered into the 68th annual Delaware Valley Science Fairs. The plural is correct as this is a compilation of 13 different science fairs across a fairly large geographic area, stretching to the Jersey Shore, Delaware, and the Lehigh Valley, bringing students whose projects have won school district and local contests to compete on a regional level. The top medal winners at the Fairs can move on to the International Science and Engineering Fair in Phoenix in May. "Judgement day" locally was on March 30 and our winners received their prizes in a ceremony the following day.

We are always are hopeful that we are able to recognize and encourage some future Engineers who we believe are deserving of special recognition. Our cadre of judges/Past Section Presidents, led by Chris Rood and assisted by Chris Menna and Bob Wright, spent the day at the Fairs and reviewed most of the over 900 individual student efforts to find those with some Engineering potential.

Even though the projects are classified into various science disciplines, including Engineering, our judges often find that they must review many projects in other areas such as physics, earth sciences, environmental sciences, and mathematics that may touch on Civil Engineering. Sometimes these projects cross different disciplines, and sometimes they are merely misplaced. The quality of many of the entries makes the decision even more difficult as well.

After a lot of reviewing (involving a good deal

of walking around the expanse of the Expo Center), our intrepid team managed to sort through a number of well-prepared projects and come up with two winners in each of the categories of Grades 6-8 and Grades 9-12.

N-ASCE* WHERE DO THE PRESIDENTIAL CANDIDATES STAND ON ISSUES IMPORTANT TO US?

Unfortunately, this article will not get to you before the Pennsylvania Primary, so it won't be able to help you make a decision for it. However, we thought we'd provide this for your information. Since the media has spent a lot of time on the personal clashes, we felt it might be helpful to review what the remaining candidates actually think their infrastructure policies will be, if elected.

You might remember that the ASCE's Report Card for Pennsylvania's Infrastructure (released in 2014) stated that Pennsylvania rates a little better than the national average, earning a Cversus a national average of D+. As a measure of the challenges we face, the National Report Card estimated the nation would need to invest \$3.6 trillion by 2020 to bring U.S. infrastructure into good repair. So what do the candidates actually think about this? Here goes a quick snapshot, in alphabetical order.

DEMOCRATIC CANDIDATES

Hillary Clinton has proposed a \$275 billion 5-year transportation bill proposal, a significant increase over the current \$225 billion FAST Act. As a Senator, Clinton served on the Subcommittee on Transportation and Infrastructure between 2007 and 2008, and voted yes on the \$60 billion stimulus package in September 2008. She also advocates for the creation of a \$25 billion public infrastructure bank, expanding public transit, investment in aviation, faster rail system, and energy infrastructure, paid by business tax reform.

Bernie Sanders created waves a few months ago by proposing his Rebuild America Act, a \$1 trillion 5-year transportation bill. He proposes to pay for this by closing corporate tax loopholes. He estimates that at least 13 million jobs would be created by such a program. He has consistently voted yes on transportation/infrastructure mea-sures, including for the 2015 FAST Act (the current transportation bill) and the 2013 Disaster Relief Appropriations Act (post-Hurricane Sandy).

REPUBLICAN CANDIDATES

Ted Cruz might be the candidate who has publicly most opposed the current transportation and infrastructure funding process, comparing the system to cartels and pork barrel politics. During his campaign, he has advocated eliminating the USDOT's New Starts Transit program and TIGER program, which fund transit and innovative / sustainable transportation investments. He has consistently opposed transportation and infrastructure bills in Congress.

John Kasich has as his main proposal for transportation to reduce the USDOT and devolve transportation funds directly to states. Accordingly, he would slash the federal 18.4 cents/gallon gas tax, leaving just a few cents to fund only interstate highways. PROJECTS IN THE NEWS MANAYUNK BRIDGE SELECTED FOR AWARD

The Manayunk Bridge Trail project, the topic of our March Section Meeting, was recently selected by the Preservation Alliance for Greater Philadelphia (PAGP) to receive a 2016 Preservation Achievement Grand Jury Award. The award will be presented to the project's Design Engineer, Whitman Requardt & Associates (WRA), at the 23rd Annual Preservation Achievement Awards on June 8 at the Union League of Philadelphia. PAGP presents these awards annually to celebrate the highest level of achievement in historic preservation for efforts involving restoration, rehabilitation, or adaptive re-use. Winners for this year's Grand Jury Awards were selected by a board of nationally recognized preservation professionals based in New York City.

PROFESSIONAL DEVELOPMENT REQUIREMENTS UPDATE

As you may be aware, Professional Engineers, Land Surveyors and Geologists in many states are required to obtain continued professional development (CPD) credit to renew their licenses in many states. Locally, this includes Pennsylvania, New Jersey and Delaware.

You may have just renewed your New Jersey license, which expires on April 30 (if you haven't, here's your reminder!). Delaware licenses will be up for renewal in June (they expire June 30). For each of these states, the license holder will need to certify that he/she has earned the required 24 professional development hours' (PDH) worth of valid instruction, training and/or education in the licensing period. This will also require ethics education (2 PDH's in New Jersey, 3 in Delaware). There is allowable carryover for PDH's that were earned prior to the last license renewal but not applied to that renewal. Please check each state's requirements as applicable.

You are likely aware that our Section's meeting program is generally able to count toward your continuing education requirement (meetings that the Section believes would not count will be prefaced as such in the meeting announcement) for many states (New York and Florida being two exceptions where coursework pre-approval by the state board is required). We continue to have a verification program in place to help our members obtain and track PDH's. Also, through our monthly meeting schedule, we generally offer at least a half-dozen opportunities for you to pick up PDH's. Over a two-year licensure period, this could amount to half of what one needs to meet many states' requirements.

Also, you may have noticed that you can earn up to 5 PDH's by choosing to attend up to 5 on-demand webinars offered by National as a free benefit of your membership. There is a list of over 60 such webinars from which you can choose. Information on this is available in the Membership section of the ASCE National website (asce.org).

And for those of you who don't yet have PE after your name and may be considering "taking the plunge" for an upcoming PE exam in the future, please check ASCE's live exam review courses. This allows one to interact with instructors during live webinars and access free on-demand recordings 24/7 until the exam date. The courses reference codes specified by NCEES for the exam. You can feel confident with the most comprehensive and convenient way to prepare for and pass the exam. More information is available on the ASCE National website (asce.org).
