

But for those who blindly walk the boards, paying attention to only themselves or whatever is two feet in front of their face, they will eventually cross paths with the beast and it will let them know, in a polite way, it isn't happy. "Watch the tram car, please" echoes through the smell of pizza and drowns out the sounds of children's laughter as those unfortunate souls who are in the way are startled from their selfishness while a tram car bears down on them at a slick speed of 5 mph.

This year, the Wildwoods celebrates the 75th season of the Boardwalk Sightseer

Tram Cars. Originally built in 1939, these cars made their way to Wildwood and helped boost business, eventually becoming a symbol of the boardwalk.

Some facts on the tram car fleet and operation:

The tram cars were originally purchased by the Greyhound Bus Company to transport visitors around the 1939 World's Fair in New York. Nine years after the Fair closed, a Wildwood business owner, S.B. Ramagosa, purchased five of the trams and brought them to his town. They began operating on the Wildwoods Boardwalk on June 11, 1949, and the cost to ride one way was 10 cents.

Originally powered by diesel engines, they were changed to battery operation when Ramagosa acquired them, thus they are ahead of their time environmentally speaking (given the current popularity of EV's). Under the hood one will find a 2400-pound 36-volt battery. Around the middle of the service day, usually between 4:30 and 5 PM, fully charged tow tractors are swapped out for those that have been in service to that point.

From 1949 to the late 1980's, the tram drivers and conductors were all females. At present the crews include a number of retirees who have settled locally and exchange students from overseas.

From the first weekend in May to the last weekend in September, the trams carry between 500,000 and 600,000 passengers, with daily loads up to 10,000 during peak season. The maximum number of trams that run at any one time is eight, with two spare tow tractors in the wings. All five of the original 1939 trains still run. In 1964, the fleet was increased by three tow tractors, with two more added within the past few years. In the 75 years of service, more than 20 million passengers have taken tram car rides.

The Ramagosa family sold the fleet to a group of local business owners in 1994. In 2002, the new owners decided to sell the trams, and at the end of the summer season, they were stored at the Cape May County Airport, and several amusement parks around the country began to make offers for them. The Boardwalk Special Improvement District (SID), a private nonprofit corporation representing the property owners on the Wildwood boardwalk, stepped up to the plate and entered into a leasing arrangement with the former owners in the spring of 2003. SID purchased the trams outright the following year.

In 1971, a tram employee asked his girlfriend, Floss Stingel, to utter a few words into a home recorder. That phrase, "Watch the tram car, please", will forever resonate in the minds of anyone that has set foot on the Wildwoods Boardwalk. It became the voice of the beast, and it only took two or three tries. The electric operation contributed to the need for this as the trams run very quietly and are not heard by strollers on the boardwalk.

Trams have transported brides, grooms and wedding parties, but as far as anyone remembers a tram has yet to be in a funeral. The Harlem Globetrotters were shuttled up and down the boardwalk on the trams during their yearly appearances in Wildwood.

#### **Leaders on I-95 Emergency Reconstruction Efforts**



After receiving a tour of the Interstate 95 highway collapse on June 17, **President Biden** provided an update on the administration's efforts to aid reconstruction efforts. He was joined by Pennsylvania officials including Governor **Josh Shapiro**, Senators **Bob Casey** and **John Fetterman**, Representative **Brendan Boyle**, and Mayor **Jim Kenney**. The collapse occurred on June 11, when a tanker truck carrying gasoline crashed and caught on fire under an I-95 bridge.

Section Director **Archie Filshill**, Founder and CEO, Aero Aggregates of North America, met with President Biden during the briefing to exchange ideas on contributing to a sustainable future together beyond the reconstruction of I-95. Dr. Filshill is also the Vice Chair of Geo-Institute's Continuing Education Committee, the Past Chair of the Delaware Valley Geo-Institute, the 2021 Philadelphia Civil Engineer of the Year, the 2023 Delaware Valley Engineer of the Year, and serves on the Geo-Institute Sustainability Committee.

Peña-Mora** as our 2024 President Elect and he will be formally inducted into this position at the ASCE 2023 Convention (more information on this is provided below). With nearly 30 years of experience in academia and practice, De, Peña-Mora serves as the Executive Director of the Center for Buildings, Infrastructure and Public Space at Columbia University in New York, where he also has been the Edwin Howard Armstrong Professor of Civil Engineering and Engineering Mechanics since 2012. He is the founder and president of Peña-Alcantara Consultants Inc.

He chaired the Construction Research Council from 2009 through 2011, the International Conference on Sustainable Infrastructure in 2017, and the Industry Leaders Council from 2020 through 2022.

Most recently, Peña-Mora served on the ASCE Board of Direction as an at-large director from 2019 through 2022, during which he also led the development of ASCE's new strategic plan as chair of the Board Strategic Advisory Council.

In addition, several Regional Directors and Governors were elected in this process. For our Region (Region 2), **Greg Kuklinski** of the Lehigh Valley Section additionally was elected to serve as Director.

# PROFESSIONAL DEVELOPMENT REQUIREMENTS UPDATE

As you may be aware, Professional Engineers, Land Surveyors and Geologists in many states are required to obtain Continued Professional Development (CPD) credit to renew their licenses in many states. Locally, this includes Pennsylvania, New Jersey and Delaware. In September, your Pennsylvania license will be due for renewal.

During your renewal process, you likely had to check your tally of professional development hours (PDH) that you needed to attest that you had to meet the minimum for renewal. As you may know, our Section's meeting program is generally able to count toward your continuing education requirement (meetings that the Section believes would not count will be prefaced as such in the meeting announcement) for many states. We also offer various Technical Group/Institute and YMF meetings and events that offer PDH credit (including the ability to view a meeting after the fact, through Teachable, and get said credit). We continue to have a verification program in place to help our members obtain and track PDH's. Over a two-year licensure period, our Section meeting program alone could amount to half of what one needs to meet many states' requirements.

Additionally, ASCE National offers free on-demand webinars and coursework that will get you up to 10 PDH's as a benefit of your membership. Information on this is available in the Membership section of the ASCE National website (www.asce.org).

### FROM THE SOMEWHAT-CLUTTERED DESK OF THE EDITOR...

Things seem to be returning to "normal" (i.e. before virus) in our everyday lives and dealings, to the extent that the virus protocols, shutdowns, etc. are all but officially no longer in effect (the lone hold-outs appear to be doctor's offices, where masks are still required). Officially, many of the precautions and protocols at the federal level expired in early May, but mainly uneventfully and not noticed by most. Some might see this as something that happened very quickly (and thankfully for that), while others might say it took longer than it should have, but either way it's a nice tribute to science and how we reacted quickly and strongly to the problem. In any event, it has been good for groups like ours to be able to have in-person meetings and network once again, and it may have taught us how valuable the in-person method is to what we do (allowing us to see each other socially, network professionally, and stay in contact). After a season of face-to-face dinner meetings, again, the value of these gets hammered home strongly.

And it's been over two months since our Spring Social, our Section's most recent event, but it feels like longer than that. We may have been hoping for a quiet summer in the Engineering world, but the emergency that I-95 became in the early hours of June 11 brought our profession back into the spotlight, even at the national level. And we responded greatly, having a solution in hand within a couple of days and getting the "fix" ready to handle traffic again (at least the I-95 mainline traffic) in an almost-unheard-of 12 days. The attention of national, state and local leaders was drawn to this, illustrating the importance of I-95 in the supply chain up and down the entire East Coast and how the detour through local and in many cases residential streets was not a viable long-term option (and some may argue that 12 days was too long, but...).

It was interesting to watch this play out, especially as our "brother" society, **ASHE Delaware Valley**, had its annual golf outing on June 12, when the extent of damage and the scope of repairs was just starting to be assessed, and how the chatter among those at the outing turned to how to fix things. In my "perch" at the putting green, to oversee the putting contest, I got to speak to many about this and also watched several others who were called back to the office to help in the effort pick up their clubs and head out early from the outing to respond to the "call of duty." Because that's what we do.

A week before that, I was in Harrisburg for the day, taking part in our annual PA Council legislative visits (see the separate report on this), and talking with elected representatives about the recently-released PA Infrastructure Report Card and the need for ongoing and increased funding for several items and areas of need. Where, in similar visits in years gone by, there would often be disagreements, with the electeds not wanting to raise taxes and not always seeing the full need for more funding (often looking toward forcing agencies to be more creative and efficient in their operations and project delivery), the conversations these days are more along the lines of us


being partners and helping each other. And even despite the party affiliation in many cases... We have successfully built relationships over the years and have shown we can help deliver what is needed, and we remain available to be resources to the electeds when they need our help. And the electeds are very willing to listen. This continues to work well.

So even though summer officially started on June 21 (and as our TV news folks will remind us, it unofficially starts on Memorial Day, but their weather forecasting co-horts will counter that meteorological summer is June, July and August), and a good deal of June has been cool, dry and very unsummerlike, summer has been an interesting time for Engineers thus far. With I-95 no longer the issue it was, the recent heavy rains and flooding have turned attention to Water Resources Engineers and the possible need to re-think the 100-year storm concept, but we'll wait and see where that may be going.

And back to where we started with the virus issues, it appears that the 3-days-in-the-office policy that many companies had instituted may be going to 4 days, as Comcast in our area is headed that way (and many other firms seemed to have followed its lead when it pushed for 3 days). Whether this is good or bad, we shall see. My desk has gotten a little (somewhat, as the title of this piece indicates) cluttered recently, which is directly related to my being there just about every day, and my observations on my daily train commute (purely anecdotally) are showing that where Tuesday through Thursday appears to be the 3-day week preference for most, Monday is starting to pick up a little. The mid-week inbound trains are surprisingly standing-room most of the time and with labor shortages on SEPTA's part there may be no immediate relief coming in the train schedule to address this. Again, we shall see...

As I get older I see the effects of it (and am often not happy with those), and one of these is the ability to forget more, resulting in my writing more down and keeping notes on devices, etc. as reminders (thus, forcing me to remember to check those reminders, so you see the vicious circle here...). I was asked a few months ago to help someone with an application for an award for me by providing some information that that person did not have (and my first impulse was to be uncooperative, since I wasn't sure I should be getting that award, but...) and I was reminded that my time as Editor of *THE NEWS* started nearly 20 years ago (August 2003, when the esteemed Sid Robin left us and unwittingly put me on a path to this "promotion"). Thus, I will be starting my 21st season as Editor in 2023-24, having 20 years at the Editor's desk somehow under my belt... As they say time flies when you're having fun... In much the same way our Section is entering Year 111 of being around, pretty impressive, still going strong.
