Partners of Scott County Watersheds

Partners of Scott County Watersheds is a nonprofit organization dedicated to improving water quality and working toward flood reduction in Scott County by providing residents, developers, environmental organizations, educators, and government officials with education, support, and financial assistance to promote and install best management practices.

Three times a year, Partners of Scott County Watersheds (PSCW) organizes the Scott County Snapshot Water Quality Monitoring Event. Over 30 volunteers monitor Scott County streams, rivers, lakes, and wetlands for turbidity, temperature, pH, Nitrites, Nitrates, dissolved oxygen (DO), phosphate, and chloride. Samples for bacteriological indicator species, such as E-Coli are also taken.

How is all this data collected? How is this data utilized? What does the data from a snapshot point of view tell us? What are the long term trends?

Find the answer to these questions and others on our July 20, 2022 virtual ASCE meeting on the TEAMS venue.
