
### Race to Renewal and Start of New Membership Year



## **Upcoming Events**

We are planning a webinar for the January meeting on Integrity Assessment of Deep Foundations (date and time to be determined). This webinar is especially geared towards Structural Engineering Institute and Geo-Institute members, but should be of interest for all civil engineers. The official description of the webinar is as follows:

"This is a recorded version of the webinar *Integrity Assessment of Deep Foundations: Principles and Limitations.* Many engineers are forced to use deep foundations due to prevailing poor soil conditions. Cast-in-place foundations installed by drilling, such as drilled shafts or augercast piles, often result in questions about their structural integrity. Studies as well as failed static tests reveal a significant percentage of foundation shafts with defects that are of concern. Various non-destructive testing (NDT) inspection methods are available to assess the evaluation of structural integrity. Several commonly used techniques will be reviewed including their operating principles and testing preparation requirements. The applications will be illustrated by several case histories, demonstrating their strengths and effectiveness, as well as their limitations. Applications will include assessing unknown foundations."

As far as other events, members of the board will attend the ASCE multi-region conference in January. Also, starting in January 2014, ASCE members can access a limited number of on-demand webinars for free! It's another great benefit to being a member and another way to earn continuing education credit. Look for more information on this soon!
