## Program: What Seismic Steel Design Is All About

*Chia-Ming Uang, Professor  
Department of Structural Engineering  
University of California, San Diego*

Significant revisions and additions of design requirements including new lateral load-resisting systems have been introduced to the AISC Seismic Provisions since it was first published in 1990. While the design requirements stipulated in these Provisions have seemingly become more complex and overwhelming over the years, the basic seismic design philosophy remains the same. A historical perspective of the code development, including the challenges faced and the strategies developed, leading to modern seismic design provisions is presented. Examples from laboratory testing are provided to demonstrate some key issues. This presentation also aims to demystify the intrinsic and yet significant relationship between the AISC Seismic Provisions and the R-factor seismic design procedure in ASCE 7, and show how they work together to provide well-designed steel building structures.

## President's Column

### Building the Urgency and Proposing Solutions for a Sustainable Future *ASCE Sustainability Summit Recap*

From January 7th through the 9th, 2016, ASCE Society Leadership and the Committee on Sustainability brought together over 100 leaders and stakeholders in the civil infrastructure and sustainability fields at the Sustainability Summit in Herndon, Virginia. Building on ASCE's aspirational Vision for Civil Engineering 2025, the group was tasked with developing an action plan to transform the civil engineers' role and practice for the future.

There were many key stakeholders present to collaborate how to not only make sustainability a key issue in front of everyone from high-level officials to engineers and down to the user, but to create a shift from the stationarity mindset of the environment to proactively design for changing conditions. As civil engineers, we are stewards of the environments. As Ron Sims, former U.S. Housing and Urban Development deputy secretary, said at the Summit, "If civil engineers open the door, we will see extraordinary things happen. If they let the door remain shut, I think the impact will be very negative."

Discussions involved how to create greater urgency to adopt sustainability practices, civil engineers' leadership role in driving sustainable solutions, tangible measures of success, and building the business case for sustainable infrastructure development. Leadership increasingly means working to serve the complete project from the early stages of project inception.

As Sims succinctly presented, our society will either succeed because of the civil engineers' skills, or we will fail because of our indifference. With this parting thought, I urge you to get engaged within ASCE and at your workplace in thinking how you can make positive changes day after day to build towards a sustainable future.

## March Speaker Bio

**Chia-Ming Uang** is a Professor in the Department of Structural Engineering at the University of California, San Diego (UCSD). He received a B.S. in civil engineering from National Taiwan University, and M.S. and Ph.D. in structural engineering at the University of California, Berkeley. He is a member of the American Institute of Steel Construction, the American Society of Civil Engineers, the Earthquake Engineering Research Institute, the American Welding Society, and the Structural Engineers Association of California. For AISC, he serves on the Committee of Specifications, Committee of Research, and Connection Prequalification Review Panel.

Professor Uang's research is in the seismic design, rehabilitation, and testing of large-scale steel structures, including buildings and bridges. Uang received the T.R. Higgins Lectureship Award in 2015 and a Special Achievement Award in 2007 for his contributions in re-

search and service to the steel industry. He also received three research awards from American Society of Civil Engineers: Raymond C. Reese Research Prize in 2001 as well as Moisseiff Awards in 2004 and 2014. Uang is co-author of two textbooks on structural analysis and structural steel design and three book chapters.
