- 1. Welcome (Ken Mika) Ken Mika called the meeting to order at 3:02 p.m.
- 2. Consent Agenda (Ken Mika)

Larry Buechel moved to pass the consent agenda as presented. Jennifer Schaff seconded the motion. All in favor, none opposed; motion passed unanimously.

- 3. Consent Agenda Items Requiring Individual Votes
- 4. Old Business
 - a. Follow-up on Wisconsin initiative for climate change impacts infrastructure working group (Tom Walther) Attachment 5
 The group continues to work on the initiative plan virtually, with the intention of delivering the initiative by year-end.
 - b. 2020 Notice of Individual Merit and Engineering Achievement Awards (Jennifer Schaff) The Wisconsin Section awards nominations are due June 1 and members have been notified via constant contact and social media, and a reminder email will be sent this week. No submissions have been submitted to-date, but submissions are traditionally entered close to the cutoff date. Ken Mika and Jennifer Schaff encouraged board members to nominate and to reach out with questions or suggestions.
 - c. 2020 Outstanding Senior Civil Engineering Student Awards and recommended changes to admin manual (Jennifer Schaff/Darrell Berry) Attachment 6
 Darrell Berry stated that there was discussion to the Awards Committee about requiring that this award be presented to a graduating senior. He stated that he is not in favor of adding this requirement for several reasons, and that it only be required that the student is a senior as currently written in the Admin Manual. After discussion, it was decided that we will put this to a vote in our annual review of the Admin Manual.

 - e. Discounted Conference registration for existing life members and retirees (Darrell Berry) Attachment 8

Darrell Berry recommended to the Board that ASCE Wisconsin Section Life Members receive a 20% discount for the Spring Technical Conference and Annual Meeting registration, eligible to those who maintain their membership with ASCE. He recommended against discounted registration for retirees.

Martin Hanson moved to have Life Members be awarded complimentary registration for the Spring Technical Conference and Annual Meeting, and that retirees, who meet the retirement definition provided by DSPS, be granted to a 50% discount on registration for these events. Tom Walther recommended offering Life Members a 50% discount instead of a complete discount.



Jared Wendt recommended considering this from a financial standpoint, and Darrell Berry recommended assuming approximately 6 registrants for Life or Retiree in this consideration. Larry Buechel questioned the administrative burden involved in screening retired status. Jennifer seconded the standing motion posed by Martin Hanson. All in favor, none opposed, Tom Walther and Gary Amel abstained due to Life and Retiree status; motion passed unanimously.

- f. Report Card Committee (Jennifer Schaff/Ken Mika) Jennifer Schaff relayed that all report card chapters have been received. Jennifer Schaff and Ken Mika are in the process of creating content for the brochure and the report. The Wisconsin Section has been working with Platform Communications for Press Release services. No date has been confirmed for the Release event yet, but the Committee hopes to have a live event if possible, and by October 1 at the latest regardless of medium.
