# Ben Volk and Nate Jackson attend the Zone IV Workshop for Section and Branch Leaders Reported by Ben Volk

The ASCE Zone IV Workshop for Section and Branch Leaders was held in Honolulu, Hawaii from February 28 to March 2, 2003. The workshop provided a great opportunity to network with fellow professionals and learn more about the American Society of Civil Engineers. The workshop was attended by Ben Volk, Columbia Section President-Elect and Nate Jackson, Columbia Section Secretary-Treasurer.

One of ASCE's primary goals is to uphold and enhance the profession of civil engineering. ASCE accomplishes this mission effectively with a \$50 million annual budget and a staff of 300 people. Approximately 60% of the budget comes from dues while the other 40% comes from publications. The ASCE compares itself to the American Medical Association or the American Dental Association when it comes to representing our profession. ASCE's point is that our profession is critical to the health and safety of the public, and, as such, we need to present ourselves in a professional manner to the public.

ASCE offers many programs that can be accessed by individual Sections including:

- State Public Affairs Grants These grants can be used to prepare statewide report cards on infrastructure, legislative days at state capitals, media training for Section spokespeople, and other activities promoting the profession of civil engineering. The Columbia Section recently used one of these grants to prepare a 50-year history of the Columbia Section.
- 2) West Point Bridge Design Contest ASCE sponsors the annual West Point Bridge Design Contest that encourages children from Kindergarten to 6<sup>th</sup> grade to consider careers in Civil Engineering.
- 3) Media Training Manual- ASCE National can provide a Media Training Manual to any section that will help them handle contacts with local media.
- 4) The Infrastructure Security Partnership ASCE teamed with many other professional organizations to form The Infrastructure Security Partnership (TISP). The goal of TISP is to minimize the effects of terrorism on the U.S. through the effective and efficient planning, design, construction, and operation of the built environment.

We also heard about ASCE's Policy #465 – Academic Prerequisites for Professional Practice. The scope of Policy #465 is "ASCE supports the concept of the Master's degree or equivalent as a prerequisite for licensure and the practice of civil engineering at a professional level."

Overall, the 2003 Zone IV Workshop for Section and Branch Leaders was a positive learning and networking experience for all who attended. Oh, and it didn't hurt that it was in Hawaii!

Nate Jackson and Ben Volk are grateful to have been selected to attend this workshop.
