## District 12 Director's Report

I just returned from the spring ASCE Board meeting in Washington DC. I also attended the OPAL (Outstanding Projects and Leaders) award banquet. One of our northwest members received the Charlie Pankow award, Magnusson Klemencic Associates for their developed of the Steel Plate/Composite Concrete Shear Wall System used for the first time Seattle's Federal Courthouse Building. The outstanding civil engineering achievement award went to the Boston Section's Leonard P. Zakim Bunker Hill Bridge.

Then the next two days, from morning till night (don't all of you members feel sorry for me), were spent in a windowless room doing the national business of the organization. Here is a summary of the highlights of that meeting.

For those members that participate nationally the Board voted to increase the per diem amount from \$75.00 to \$100.00 per room night. Depending on budget priorities this may not go into effect until 2006. This is the first time this has been increased since 1988. However, in order to mitigate the budget impact committees will be required to do more teleconferences and email and avoid face to face meetings.

As members we will have two official nominees for President-elect to vote for this year. The Board nominating committee voted to send to the membership as official nominees Conrad Keys from New Mexico and Dennis Martenson from Minnesota. You will get the opportunity to vote for one of these members in June. This is an important election as we also will be voting on a constitutional amendment changing our form of governance. So the bad news is that the Board in an initial vote approved a \$10 dues increase. Why? A variety of reasons. First, inflation alone eats up \$5 of that increase. With that we are still able to fund a number of existing programs including: 1) Continuation of the congressional fellow, which has increased the ASCE voice in Congress. 2) Key contact program, which notifies you the members of key federal issues that we need you to correspond with your federal legislators. 3) State Government Affairs programs, which provides money to the local sections helping them participate in the state legislative process protecting our interests. 4) West Point Bridge Design program, one of our outreach programs to high school students. (see below for northwest winners) 5) Continue our dues to ABET, which accredits our engineering schools. 6) We are required to replenish our reserves lost through devaluation of our stocks during the economic downturn. So then why the second \$5? Here is what we as members get for the second \$5. 1) A new infrastructure report card, which has been extremely valuable in educating the public as to the needs in this country. 2) Seed money into a new certification program in the hopes of generating long term revenues. So what are we not funding? We are not funding an expanded K-12 outreach program even at a time when civil engineering enrollments are declining and engineering enrollment overall is flat. We cut the national presidents overseas trip. We did not fund an advertising campaign to be used to reinforce the ASCE identity and reputation among the public and policy leaders. In addition in the past year staff has been cut at the national level, travel by volunteers cut, and cost control measures implemented. Although an increase was approved in the per diem the Board did not address the budget impact for 2005. As a result unless the budget impact is addressed in 2005 this change will not occur until 2006.

The next meeting of the Board of Direction is schedule for July 23-24, 2004 in Seattle. This will be our chance for the Pacific Northwest to show off our area. I know I am probably not making these board meetings sound like too much fun, but if you can spare the time I recommend you attend at least part of the meeting. With the exception of the executive session these meetings are open to you the members and many of the reports presented will give you an opportunity to learn more about what programs ASCE does with volunteers for us a members.

Don't forget to vote. Your ballot should come in your June ASCE news. Please look for it.

In non Board member news, I am please to report that several high school students in our District reached the semi finals for the West Point Bridge competition and one student was awarded 5<sup>th</sup> place. The northwest winners are:
