Dear Members:

Our luncheon speaker for our May 21st meeting will be Daniel R. Haller, PE, who is with the Department of Ecology in Yakima. Dan will speak on the Columbia River Management Plan.

This is a major program which encompasses water rights and water management issues along the Columbia River and its tributaries. Specific topics will include the Lake Roosevelt Drawdown, the Quad Cities Water Rights, the Conservation Plan in the Walla Walla Valley and the KID water permit from the Yakima River.

Dan Haller is an engineer in the Columbia River Program for the Washington State Department of Ecology, where he focuses on permitting and funding water supply projects. Dan helps coordinate such projects as the incremental storage releases from Lake Roosevelt, Ecology's conservation and storage grant program, aquifer storage and recovery projects and pump exchanges.

This topic should be of broad interest to our membership from Yakima to Walla Walla. Please note that we are returning to the Shilo Inn in Richland for this luncheon meeting.

HOWARD PRESTON SCHOLARSHIP AWARD

The Columbia Section of the American Society of Civil Engineers invites applications for the Howard Preston Scholarship Award. The purpose of the scholarship is to promote excellence and professionalism in the field of Civil Engineering. The scholarship will provide financial support for the student's educational expenses.

There are two scholarships to be awarded this year: One in the amount of \$1,500 to a qualifying Junior, and one in the amount of \$500 to a qualifying Senior. Scholarships are in the form of certificates of award conditioned upon the enrollment of the student as specified under student eligibility requirements. Upon receipt of notice of enrollment from proper officials, a check for the amount of the award will be forwarded to the college or university to establish a credit for the student. Unexpended credit is subject to withdrawal if conduct of student is contrary to the intentions of ASCE.
