The following items were discussed:

1. Report from Region 1 of ASCE
 - 1.1 January 9-10 - Regions 1, 2, 4 & 5 MRLC in Jacksonville, FL, Recap – Rich Cohen and Mike Ciacciarella attended this event on behalf of CSCE. The event went really well and offered great informative sessions. Rich Cohen attended sessions that focused on section/branch issues while Mike Ciacciarella attended sessions focused on Younger Member issues. One point that was raised by many attendees is that people would like to spend more time with their ASCE governors.
 - 1.2 March 18-20 - ASCE Legislative Fly-In in Washington, DC – Tom Wamser and Randy States are attending this on behalf of CSCE.
 - 1.3 May 12-13 - Region 1 Spring Assembly - Albany, NY – ASCE will be holding this event in conjunction with the NYS Council Convention.
 - 1.4 April 17th ASCE Student Symposium will be held at Roger Williams University in RI.
 - 1.5 Report from ASCE Treasurer Mario Ricozzi:
 - ASCE has started budgeting for Fiscal Year 2027 and it recently approved recommendations related to workforce development and retention.
 - ASCE is looking at opportunities to reach students in younger grades. Since CSCE visits many schools to speak with students about careers in civil engineering, CSCE may be asked for feedback on these opportunities.
 - On December 2nd, he represented ASCE in a presentation on the WALK Bridge project in collaboration with representatives from the American Council of Engineering Companies (ACEC) and the American Public Works Association (APWA). This project is a good example of community investments in infrastructure.
2. Review/Approve CSCE Board Conference Call Minutes from CSCE Board Meeting on December 19, 2025 – Tyler Parker made a motion to approve the minutes from the CSCE Board Meeting on December 19, 2025. Jodi Constant seconded the motion, and it passed unanimously.
3. CSCE Executive Board Activities
 - 3.1 Treasurer: Jodi Constant now has access to all of CSCE's Webster accounts. She provided the balance of those accounts to the Board. She is now gathering information for CSCE's tax filing to provide to ASCE and information for Amy Petrone's tax form. To help complete the Treasurer's files that she now maintains, Byungik Chang will give the binder with information from 2023-24 to her soon.
 - 3.2 ASCE Grant Application from SEI-CT: Sanjeev Mohan recently submitted a \$500 grant application on behalf of the SEI-CT to ASCE to support the SEI-CT Student Career Forum at CCSU. After reviewing the application, some

ASCE Regional Governors wanted to see a full breakdown of event cost schedule. In response, Sanjeev Mohan will provide that information to ASCE.
