1. Report from ASCE Region 1

- Broadcasting webinars that offer NYS PDHs to NYS engineers Aaron Foster, Scott Nolan and Tyler Parker are looking to do this in the future. CSCE could promote its webinars more to engineers outside of CT.

2. Review/Approve Minutes from CSCE Meeting on March 3, 2023

- YMG Bylaws The Bylaws have been sent to Scott Nolan for his review.
- YMG is interested in looking into rebranding YMG to a different name (something like Future Leaders).
- A new member is Gregory Castater.
- Virtual PE & More Tell All at Lunchtime on April 19, 2023 People should reach out to Tom Wamser if they can help out. If you work with someone with a unique credential, please let Tom know.
- Hartford Yard Goats Game Trip Details are being reviewed. The trip could be in summer/fall.
- Site Tour United Concrete is open to offering a technical tour in the next couple of months. The tour could be from 3-4 p.m. followed by a social at a local brewery. CSCE may be able to offer NYS PDHs for the tour.

5. CSCE Executive Board Activities

5.1 President's Report – Scott Nolan

- March 2023 Meeting at Norwalk Inn A couple of meeting attendees were interested in getting more involved with the Fairfield County Branch. Aaron Foster is in contact with them.
- Wolcott High School Visit He and Rich Cohen visited this high school to talk about civil engineering with high school students.
- Recruited two colleagues to join CSCE (one this year, one will join next year cycle). One of them showed interest in Institutes (Water Resources & Coastal?).

5.2 President-Elect's Report – Aaron Foster

• Annual Corporate Sponsorship – CHA is interested in paying for an annual sponsorship with CSCE. CSCE needs to determine the specifics of the sponsorship. CSCE could reach out to other local organizations like WTS for the details of its corporate sponsorships. Companies may want sponsorships to include registrations to dinner meetings, logos on mailings, emails and signage at CSCE events, job postings, or a foursome at a golf outing. CSCE currently offers one corporate sponsorship. Aerix Industries currently pays \$360 to CSCE for 6 months (\$60/month) to put its logo on the CSCE general emails. ASCE may list some best practices related to annual sponsorships on its website.

5.3 Report from Treasurer – Tyler Parker

- There is approximately \$25,000 in CSCE's bank account and \$9,000 in CSCE's PayPal account. He will send reimbursement checks to Amy Petrone, Aaron Foster and Scott Nolan, and place a stop payment on an uncashed scholarship check from 2022. There is no bank fee to place the stop payment.
- Scholarships Based on sponsorships and ACE Awards, CSCE can review whether it needs to pay for scholarships from the Scholarship Fund instead of its operating budget.
- Card Reader He will look at the options soon, including those from Square and Webster Bank.

- He will have an annual budget framework for the Planning Meeting. In the future, before the Board decides about spending money, it should review its budgetary information.
- He will upload local budget information to the CSCE/ASCE online version of Quicken.
- 5.4 Report from Secretary Eric Hoyt CSCE submitted its annual report to ASCE.
- 5.5 Report from Newsletter Editor Sam Turek He is working on the April CSCE newsletter.
- 5.6 Report from Director I Brianna Ritacco
- She received a list of people with outstanding payments from ASCE. She will reach out to them.
- Operations Manual She is working on updates to the manual.
- City Steam Tyler Parker will check if CSCE has paid all its invoices from City Steam and let her know.
- She will check with the DOT Commissioner to see if he can speak at a September CSCE dinner meeting.

The program has been developed and sponsors have all signed up. There are exhibit tables still available. The Chapter has also begun to plan the next GEO-CT Conference that will be held on September 22, 2023. The GEO-CT.org website promoting the conference is up and running. Amy Petrone will add a link to it on the CSCE website. If CSCE can get a Square reader before the conference, it could be used for conference payments.
