The following items were discussed:

- 1. Report from ASCE Region 1 Governor Danielle Spicer:
- 1.1 She can be on the call for the CSCE Planning Meeting to induct the 2023-24 Executive Board officers. Scott Nolan will ask her for her availability in June. Brianna Ritacco and Scott Nolan will work on setting up a When2Meet availability survey for the CSCE Planning Meeting.

- 1.2 Save the Date September 29-30, 2023 ASCE Region 1 Fall Assembly in Montreal
- 2. Review/Approve Minutes from CSCE Meetings on April 7, 2023, and April 28, 2023

Scott Nolan made a motion to accept the minutes from the CSCE Meetings on April 7, 2023, and April 28, 2023. Brianna Ritacco seconded the motion and it passed unanimously.

- 3. Monthly Dinner Meetings
- 3.1 April 18 In-Person Dinner Meeting at the USCGA This meeting was a success.
- 3.2 May 17 Virtual Lunch Meeting on Bicycle Lanes This was a good presentation and the speaker offered to run a follow-up presentation. CSCE may reach out to her again to give a future presentation.
- 4. Annual Events / Critical Discussion Items
- 4.1 Event Management Platforms ASCE is not going to be using Constant Contact after July 2023. So, sections of ASCE must soon determine their new event management platforms, which could include Thrive/Informz via ASCE, Eventbrite, and Constant Contact. Landon Barlow looked into using Eventbrite to manage the registration for the 2023 GEO-CT Conference scheduled for September 22, 2023. Fees charged by Eventbrite are 6.6% plus \$1.79 per ticket and its email marketing costs are separate.

4.2 Card Readers – Since people continue to experience challenges when trying to pay for an online event registration with a card and no PayPal account, CSCE is looking into buying a card reader that could be both used for online registration payments and in-person event payments. Scott Nolan will follow up with Tyler Parker regarding his research into card readers. This is an important issue for CSCE. Tom Loto shared that companies increasingly want employees to use company cards to pay for events.

4.3 Younger Member Group (YMG) Update:

- 4.3.1 Alex Klose introduced Tom Wamser officially as the next YMG President. The YMG just held elections. Tom Wamser was elected President, Sanjeev Mohan was elected Vice President and Ariana Antonucci was elected Secretary. Congratulations to all! The YMG also had new general members join recently.
- 4.3.2 In May, the YMG coordinated a site tour of the United Concrete Plant on the 11th and 26 people attended the tour. United Concrete is interested in hosting another site tour in the future. This summer, the YMG could host a trip to a Hartford Yard Goats game at the end of August/beginning of September. Scott Nolan will look into sponsorships and support for this trip. The New England Water Environment Association (NEWEA) and the Women's Transportation Seminar (WTS) are also planning trips to see Yard Goats games this summer. The YMG may be able to coordinate a trip with them. At past joint CSCE-ACEC trips to Yard Goats games, people paid full price for their tickets and CSCE had had to pay a downpayment to the Yard Goats ahead of the game.
- 4.3.3 The YMG is constantly looking for STEM outreach opportunities, i.e., it plans to hold a resume review in the fall.
- 4.3.4 The YMG has a \$250 grant to support student retention that needs to be used by August 2023.
- 4.3.5 The YMG is interested in planning a trail clearing/clean-up event.
- 4.3.6 The YMG is finalizing its bylaws. Tom Wamser would like to edit them before sending them to the CSCE Board and ASCE for their review and approval.

4.4 ACE Awards Re-cap

- 4.4.1 6 project awards and 5 individual awards.
- 4.4.2 From responses to the event evaluation survey, the timeline worked well, and a couple of people requested more appetizers.
- 4.4.3 Katie Hedberg-Klose talked about the contents of an email she sent to the CSCE Board and ASCE representatives on June 1st about the event's ASCE presentation that included an incorrect statement that women decide to leave the field of engineering because men aren't teaching women civil engineering in a way to make them stay. The Board discussed how it would address this incorrect statement. CSCE could put together an action plan to increase the number of Justice, Equity, Diversity & Inclusion (JEDI)-related events it hosts and how to address JEDI issues in the future. While CSCE is encouraged that 43% of the CSCE scholarships went to female students this year, not many events related to JEDI have been hosted by CSCE recently. This topic could be part of the agenda for the Planning Meeting. In the meantime, CSCE will ask ASCE to meet early next week to discuss this issue and get a recommendation from ASCE as to how to communicate with the CSCE membership about the issues raised in the ASCE presentation. CSCE could send an email to the attendees of the ACE Awards related to the ASCE presentation to address the issues raised in it. CSCE should work with ASCE to move forward with this effort.

- 5.7.1 He is interested in continuing as the Finance Committee chair.
- 5.7.2 The Committee Chairs and Institute Chapter Chairs should have their budgets prepared for the Planning Meeting.
- 6. Reports from /Institute/Committee Chairs/Fairfield County Branch
- 6.1 CT Chapter of the ASCE Structural Engineering Institute Chair: Byungik Chang He sent the following information to Scott Nolan and Amy Petrone this morning:
- 6.1.1 SEI Structures Seminar on October 20, 2023
- 6.1.1.1 A formal invitation letter was sent to all 6 speakers, and they have confirmed their presentations.
- 6.1.1.2 The Chapter is updating its seminar survey, which will be sent to all participants after the seminar.
- 6.1.1.3 The same lunch package that was used last year will be used this year.
- 6.1.1.4 The estimated number of participants is about 40.
