## 5. CSCE Executive Board Activities

- 5.1 Report from President Scott Nolan/Aaron Foster
- 5.1.1 The Board discussed offering annual sponsorships to companies. Aaron Foster made a motion to offer an annual sponsorship of \$2,000 per year for highlighting the sponsor at the beginning of each dinner meeting presentation on an opening PowerPoint slide, on postcard, on emails sent by CSCE, and 5 registration vouchers for monthly dinner meetings (excluding the ACE Awards Ceremony in May). Scott Nolan seconded the motion and it passed unanimously.
- 5.1.2 CSCE should utilize the PDH Certificate Generator to save time & efforts when distributing PDH certificates, keeping records, etc.
- 5.1.3 The Board discussed establishing a geotechnical-specific scholarship. Aaron Foster made a motion to set aside \$1,000 for a geotechnical engineering sponsorship for which the CT Valley Chapter of the ASCE Geo-Institute will solicit nominations and award a scholarship for a CT resident going to study civil engineering or a civil engineering student going to a college/university in CT. Rich Cohen seconded the motion and it passed unanimously.
- 5.2 Report from President-Elect Aaron Foster/Rich Cohen
- 5.2.1 CSCE should reach out to WTS to host a joint event.
- 5.2.2 CSCE should start in March/April 2024 to discuss an increase to its Section dues since the form is due in May.
- 5.3 Report from Vice President Rich Cohen will share information with Tyler Parker about the Vice President's responsibilities.
- 5.4 Report from Treasurer Eric Hoyt will contact Tyler Parker about the Treasurer's files and the cloud-based Quicken files.
- 5.5 Report from Secretary Eric Hoyt and Sam Turek will review the Secretary's files in July.
- 5.6 Report from Newsletter Editor Sam Turek and Danielle Morin will review the Newsletter Editor's files in July.
- 5.7 Report from Director I Brianna Ritacco/Scott Nolan Brianna Ritacco will be the chair for the CSCE Past Presidents' Council. She wants to host another event for Past Presidents in 2023-24. CSCE will review its budget before making a decision about the funding for this Past Presidents' event.
- 5.8 Report from Director II George Gerard/Brianna Ritacco George Gerard would like to serve on the Scholarship Committee and/or the Audit Committee in the coming year. He also suggested that CSCE consider having an in-person

Board meeting in January or February 2024 at Elizabeth's in Rocky Hill, CT, as it had done before the pandemic, to strategize about the year's events.

- 6. Reports from Technical Group/Institute/Committee Chairs/Fairfield County Branch
- 6.1 ASCE Environmental & Water Resources Institute CT Chapter Chair Tom Loto shared the following information with the Board:
- 6.1.1 September 12th is the Annual Golf Outing for AWWA is scheduled for September 12, 2023.
- 6.1.2 Upcoming events from affiliated organizations include the Annual NEWEA Conference & Exhibit in Boston on January 21-24, 2024; the NYWEA Conference on February 5-7, 2024, the NEWEA Spring Meeting on May 19-22, 2024; in Newport, RI; and the NYWEA Spring Technical Conference during the first week in June 2024.
- 6.1.3 He will reach out to volunteers to help plan activities for this Chapter. He may look into hosting a joint event with CTWEA (Connecticut Water Environment Association), which is the organization that resulted from the merger of the Connecticut Water Pollution Control Authority (CWPCA) and the Connecticut Water Pollution Abatement Association (CWPAA).
- 6.2 ASCE Geo-Institute Connecticut Valley Chapter The Chapter is hosting its 2<sup>nd</sup> Annual GEO-CT Conference on September 22, 2023, and a Geotechnical Seminar in spring of 2024.
- 6.3 ASCE Structural Engineering Institute CT Chapter The Chapter is hosting a Structural Engineering Seminar on October 20, 2023.
- 6.4 Legislative Affairs Committee Aaron Foster will reach out to Chris Fagan to see if he wants to work with Roy Merritt on this committee.

- 6.6 Scholarship Committee Chair Jim Sime sent a scholarship report to the Board, but he was unable to attend this meeting. In the report, he requested that CSCE authorize subscribing to the new Brinker Advisor service either for six months or for 1 year. The Board discussed his request and wondered if a subscription is necessary since the recommendation in the report is to continue to maintain the Board-approved Policy Portfolio Asset Allocation percentages in each asset class investment through periodic re-balancing. It was decided that George Gerard will ask Jim Sime to give an overview of the Brinker newsletter/website at a future CSCE Board meeting.
- 6.7 Golf Outing Committee –Nathan Rossi helped manage this great event on behalf of CSCE.
- 6.8 Younger Member Group President Tom Wamser shared the following information with the Board:
- 6.8.1 Yard Goats Game Trip at the end of August SLR Consulting may be a sponsor for this event. Several other technical groups/companies are planning trips to Yard Goats games in August as well including CTAWWA on September 1<sup>st</sup>, CTWEA on August 4<sup>th</sup>, WTS on August 3rd, and AECOM on a date TBD. Tom Wamser and Scott Nolan will talk after the meeting to pick a date for the YMG trip.
- 6.8.2 YMG Bylaws Review Scott Nolan needs to review the bylaws.
- 6.8.3 The YMG could have possible trail clean up with EWB (Engineers without Borders).
- 6.8.4 There are now 3 active YMG members in addition to the elected officers.
- 6.8.5 A potential field trip is to visit the Stratford Wastewater Pump Station.

- 6.8.6 He is interested in submitting a YMG award nomination to ASCE on behalf of the CSCE YMG before February 1, 2024.
- 7. Goals / Open Discussion:
- 7.1 Scott Nolan would like CSCE to aim to increase the CSCE Membership to 2,000 CSCE members by the 2024 ACE Awards.
- 7.2 Scott Nolan will explore the idea of having the PDH Credits people earn lead to a discount of the fees paid for their PE Renewal Application each year.
