1. Report from Region 1 of ASCE - Region 1 Governor Geoffrey Schwartz:
  - 1.1 January 9-10, 2026 - Regions 1, 2, 4 & 5 MRLC in Jacksonville, FL – Mike Ciacciarella, Rich Cohen and Aaron Foster will be attending this event.
  - 1.2 March 18-20, 2026 - ASCE Legislative Fly-In in Washington, DC – Aaron Foster will be attending this event.
  - 1.3 Nominations for 2026 ASCE Director or Governor Election are due by December 1<sup>st</sup>.
  - 1.4 Congratulations to Aaron Foster and Rich Cohen for becoming Region 1 ASCE Governors. There are 7 different Governors in Region 1 and their 3-eyar terms run from October-September annually. Rich Cohen will represent the New Jersey Section and Aaron Foster will represent CSCE. They can serve on the CSCE Board and as Region 1 Governors simultaneously. Anyone can reach out to Geoff Schwartz, Aaron Foster and Rich Cohen for information about activities in Region 1.
  - 1.5 ASCE Student Symposium in April 17-18 – This event will be held at Roger Williams University in Rhode Island. CSCE is part of ASCE’s New England region for these types of events. CSCE should reach out to the ASCE Student Chapters to encourage them to attend these events. ASCE is having monthly symposium check-in calls to prepare for the event.
  - 1.6 At the end of October, CSCE submitted an Outstanding Section and Branch application to ASCE.

    - CSCE still needs to schedule a speaker for the CSCE Dinner Meeting at the U.S. Coast Guard Academy on April 14, 2026. Rich Cohen has reached out to speakers about a presentation related to the CT Port Authority/State Pier.

- Stone Bridge Crossing (SBC) in Cheshire, CT – This could be a future dinner meeting topic or webinar.
- CSCE could host a presentation on the implementation of the Greater Hartford Mobility Program at a future dinner meeting.

- November 20 – 12 p.m. webinar on Bicycle Infrastructure – The presentation went well and the speakers shared information on different cities and metro areas in CT and highlighted projects in cities that implemented bike lanes.

### 5. Reports from Younger Members Group, Institute/Committee Chairs, and the Fairfield County Branch

#### 5.1 Past Events held by the Fairfield County Branch, SEI-CT, and the YMG:

- October 22<sup>nd</sup> CTDOT Highway Operations Center Tour at 12 p.m. – This event was well received and had about 10 attendees.
- October 25<sup>th</sup> CSCE YMG Career Path Roundtables at CCSU at 5 p.m. – This event was very well received and had about 20 attendees.
- October 29<sup>th</sup> YMG Quinnipiac University Alumni Panel – Three alumni spoke with 10 students about careers in civil engineering.
- October 30<sup>th</sup> Fairfield County Branch Social at Elicit Brewing Company in Fairfield, CT at 5:30 p.m. – The Branch had a good turnout for this event.
- November 7<sup>th</sup> SEI-CT Seminar at the Hilton Garden Inn Hartford South/Glastonbury, in Glastonbury, CT – This event had 80 attendees including 25 students, 11 poster presenters judged by volunteers, 6 student poster prizes, and 6 sponsors. The SEI-CT Chapter members sent a reimbursement request to the CSCE Treasurer. People discussed how CSCE handled past scholarships and if checks were given directly to students or to their schools. Jodi Constant attended this year's seminar and thought the event went really well.
