We had a guest from MNDOT talk about district 1 bridge construction and maintenance. We also had an alumni, Ben Kern talk about water resources

engineering in the Pacific Northwest and what kind of stormwater management projects they are doing in Washington to reduce polluted run-off. In September we also got out and did a trash pick up with our club to clean up our Adopt a Highway section of US Hwy 53 about 20 miles North of Duluth.
