Topic: Combined Sewer Overflow (CSO) Program Status

On average, more than 300 sewage overflows send millions of gallons of raw sewage and stormwater into Seattle's creeks, lakes, the Ship Canal, the Duwamish River, and Elliott Bay. These combined sewage overflows create significant health and environmental risks.

In King County, CSOs are only located within the City of Seattle, so the County and City are working together to control CSOs and keep sewage and stormwater out of local waterways.

This presentation describes the City and County's CSO systems, past efforts that have been made to improve the systems, and the City and County's current approaches to combat these challenges and improve the health of our waterways. Examples of completed and ongoing projects will be described as well as plans for upcoming projects to address a Federal consent decree that requires specific performance objectives.

### **December Member Meeting Recap**

Secretary Roger Millar presented a straightforward and detailed summary of efforts underway at WSDOT to better incorporate facility maintenance funding into the overall asset management funding conversation with the legislature. Secretary Millar described the current strategic plan moving to innovative stewardship using a practical solutions model. For more details

Secretary Millar described the work being done to analyze and identify parts of the infrastructure with a grading system to systematically prioritize the highest and best use of public funds to keep Washingtonians moving safely through practical solutions and practical design. Work going on right now includes enhancing prioritization methods and software tools to compile, assess and rank repair and maintenance activities across the agency. He emphasized the important of being a good steward of the many existing facilities under DOT jurisdiction critical to public use (airports, highways, ferries and associated storm water conveyance systems).

He also described some current research efforts underway to help optimize how WSDOT's Incident Response Team responds to flow disruption events for people and goods.

In the spirit of creating work opportunities for all our citizens, Secretary Millar described the current plan for contracting goals on state-funded projects. This plan presented new state-level contracting goals that honor both the historic federally mandated contracting goals, intended to provide equal opportunity, as well as a new system which sets a state-level goal for the small business owner without any other demographic association. This is very exciting because it helps to honor ever increasing diversity in the technical engineering field and honors historical actions to grow opportunities for all citizens. The result is pending certification by ICC's rules committee.

Thanks to those of you who contacted local building officials and fire marshals to urge their vote for ASCE 7-16, defeating an effort by the National Association of Home Builders to block the standard.

## Richard Williamson Jones Scholarship

The Seattle Section is seeking applicants for the Richard William Jones Memorial Scholarship. The Scholarship was established by his wife, Kathie, because Richard often commented that when he was a student, he would have been much better off if he had just had a little more money for books and supplies. The scholarship continues through Kathie Jones' estate.

Richard Jones was a civil engineer and a member of the Seattle Section of ASCE, when he died in an airplane crash at the age of 53. He was a graduate of the University of Washington and was admitted as a Member of the Society in 1949 and as a Fellow in 1959.

Mr. Jones joined General Construction Company in 1933, where he worked on many projects in the Seattle and Portland area, including the Bonneville Dam and as Chief Engineer on the Hungry Horse Dam. At the time of his death, he was Executive Vice President of General Construction Company.
