# President's Column

# Where to send those Hard Copy Design Guides and Books?

Recently, the ASCE Board has received a couple of inquiries about where to send important design guides and older technical publications that are no longer being used due to the inevitable transitions in life. ASCE National recommends contacting the Linda Hall Library. I encourage donors to consider both National and local university options (which includes



considering individual alma mater for book donations). In some cases books may be purchased by universities so it's a good idea to ask. It's also a good idea to consider tax deductions that may be associated with the value of items being donated.

The concept of where to give is worthy of contemplation to determine the philosophical best fit for content. In some cases special attention should be paid to the value of local giving when one considers the uniqueness of regional works. The legacy may be best fit for those who carry out the maintenance of previous projects designed and built here.

The Linda Hall library is an important resource because it is, from my understanding, the largest historical collection and storage library for historic engineering publications. Another interesting fact is that the local universities aside from St. Martin's are publicly funded institutions, classically underfunded to purchase works. The University of Washington's College of Built Environments (home to the fairly new construction management program) does not have a large budget for purchasing content related to construction practices as they are a newer college. The College of Built Environments library and the civil engineering library work together so students can utilize technical resources donated to either focus area.

# DC Fly In Update

Following the national release of the 2017 infrastructure report card, ASCE held its annual legislative fly-in on March 14 and 15 in Washington, D.C. ASCE organizes

this annual event as a way for ASCE members from around the country to meet with and inform their local leaders on the importance of improving and maintaining our nation's infrastructure. Despite inclement weather, this year's event attracted over 200 ASCE member delegates from 49 states. This year six

delegates from Washington State participated in the flyin to meet with and discuss infrastructure issues with our state legislative members. The Washington State ASCE members attending this year's fly in included Kali Dickerson, Conrad Felice, Benjamin Hoppe, Henry Kopelman, Roger Millar, and Sharon Zimmerman. On the afternoon of March 14 and the morning of March 15, the fly-in delegates heard from members of Congress and ASCE leadership on specific issues and concerns relating to the state of the nation's infrastructure. On the afternoon of March 15 our Washington State delegation met with representatives from the offices of Senators Murray and Cantwell as a group and individually with house representatives Adam Smith, Susan DelBene, Dan Newhouse, Pramila Jayapal, and Jamie Herrera Beutler. Leading off with the ASCE grade report of D+ for the current state of our nation's infrastructure, the delegation highlighted the importance of increased and continued funding for the FAST Act, sustaining support for the state revolving fund related to water projects, and the need to support the dam and levee safety programs. Additional issues discussed included the continuation of a tax-exempt status for municipal bonds and their importance for state and local governments to finance infrastructure projects and the need for labor training and education programs to meet the upcoming

construction needs on infrastructure improvement projects.

All ASCE members are encouraged to obtain a copy and review the content of the 2017 report card that gives our nation's infrastructure grade of D+ (<u>http://</u><u>www.infrastructurereportcard.org</u>). The current grade of Washington State's infrastructure is C based on the 2013 report card. Our Washington State infrastructure report card is being revised this year and we are looking for volunteers to assist in the work. We all have a responsibility and encourage you to get involved.

#### ASCE Participation in the 100th Anniversary of the Hiram M. Chittenden Locks and Lake Washington Ship Canal

ASCE Seattle Section is recognizing the Centennial of the Hiram M. Chittenden Locks and Lake Washington Ship Canal by participating in several events throughout the year.

This facility is important to ASCE because it was designated as an ASCE National Historic Civil Engineering Landmark in 1997. The facility, completed in 1917, is significant because they were the first locks constructed, and still the only ones capable of handling ocean-going vessels, on the Pacific Coast of the United States. At the time it was the only lock facility in the country that separated fresh and salt water using a unique water sump and drain system, and the only one accommodating tidal fluctuations.

The Friends of the Ballard Locks has organized events for National History Month at the Locks in the month of May. The posters that were prepared for the ASCE Seattle Section Centennial will be on display from Monday, May 1, to Wednesday, May 31, at the Chittenden Locks Administration Building, 3051 NW 54th Street, every day 10 a.m. to 3:00 p.m. Also on display is a 6-foot-long model of the S.S. Roosevelt, which was the official boat on Opening Day 100 years ago. Our ASCE Seattle Section K-12 committee will have children's activities on site from 10:00 a.m. to 2:00 p.m. on Sunday, May 7, and at the same time the Center for Wooden Boats will have a children's boat building activity. At 1:00 p.m. that day there will be a ceremony honoring the craftsman who built the aforementioned display model boat, Clayton Naset. Our ASCE Seattle Section History & Heritage Committee will also be participating in the Chat with a Historian sessions that will be held in the Administration Building from 1:00 p.m. to 3:00 p.m. on May 6th, 7th, 20th, and 21st.

ASCE is going to be presenting a plaque in honor of the Locks centennial to the U.S. Army Corps of Engineers in a ceremony at the Locks on Tuesday, July 4th.

Our Seattle Section meeting in October 2017 will feature David B. Williams, who has an upcoming (anticipated publication date June 2017) book about the history of the Chittenden Locks: *Waterway: The Story of Seattle's Locks and Ship Canal*.

### Dr. Conrad Felice, Ph.D., P.E., P.Eng., D.GE.,

**F.ASCE** is an ASCE Fellow, the Managing Principal at C. W. Felice, LLC and an Adjunct Professor in the Department of Civil & Coastal Engineer at the University of Florida. He is a professional engineer registered in 17 states and four Provinces in Canada. Dr. Felice is a retired U.S. Air Force Civil Engineering Officer with 27 years of service and held the rank of Lt Col. For 2017 he was the Washington State Leader for the annual ASCE Legislative Fly-In. He is the current chair of AFF60, the tunnel and underground structures committee of the Transportation Research Board
