Seattle Waterfront Program

**Speaker: Jessica Murphy PE, City of Seattle,
Office of the Waterfront and Civic Project**

The City of Seattle is rebuilding Seattle's central waterfront. Now that the Alaskan Way Viaduct removal is complete, the City is constructing a park promenade along the water, building a new surface street along Alaskan Way, rebuilding Pier 58 and Pier 62, building an elevated connection from Pike Place Market to the waterfront, and improving east-west connections between downtown and Elliott Bay. This effort, called Waterfront Seattle, is a \$728M, multi-year investment between now and 2024. It is led by the City of Seattle's Office of the Waterfront and Civic Projects. WAsafe is a new program to train, enroll and dispatch volunteers to perform post-disaster building safety assessments. These volunteers can assist city and county building officials whose workload, following a disaster such as an earthquake, flood, or catastrophic storm, is expected to be overwhelming.

There will be a pressing need to evaluate homes, businesses and shelters to confirm they are safe to occupy after a large disaster. Local governmental building officials will need additional labor resources to perform thousands of assessments on partially or significantly damaged buildings.

The Richard Williamson Jones Memorial Scholarship was established by his wife, Kathie, because Richard often commented that when he was a student, he would have been much better off if he had just had a little more money for books and supplies. The scholarship continues through Kathie Jones' estate.



Richard Jones was a civil engineer and a member of the Seattle Section of ASCE, when he died in an airplane crash at the age of 53. He was a graduate of the University of Washington and was admitted as a Member of the Society in 1949 and as a Fellow in 1959. Mr. Jones joined General Construction Company in 1933 where he worked on many projects in the Seattle and Portland area, including the Bonneville Dam and as Chief Engineer on the Hungry Horse Dam. At the time of his death, he was Executive Vice President of General Construction Company.

The maximum scholarship amount distributed annually is \$2,000.

ASCE Seattle Section is searching for volunteers to assist with the Legislative Affairs Committee. The committee is interested in a Legislative Drive-In to Olympia during the 2020 WA State Legislative Session.

The Legislative Committee functions in the political arena with focus on federal, state, county or other governmental issues that are of interest to the civil engineering profession; such as university engineering budget considerations, issues that affect the practice of or employment of civil engineers, and environmental issues of significance to the profession. The committee reviews proposed legislation and comments on it with regards to its effect on the civil engineering profession and may also be called upon to testify at Legislative hearings or for other governmental committees. It is also responsible for disseminating information from the Architects and Engineers Legislative Council (AELC) pertaining to state legislation. The committee typically sends at least one representative to the Society's annual Legislative Fly-In in Washington D.C.


