The April Monthly Meeting was on April 18, 2016 at the University of Tennessee's Tickle Engineering Building (during the UTK student chapter's regularly scheduled meeting). The Joint Meeting with the Student Chapter was held to install newly elected officers for new school year (2016-2017).

The students provided a report on their participation in the annual ASCE student conference in which the students placed second overall and their year's activities.
