Project Spotlight

Green Mountain Power Middlesex Dam Spillway Rock Anchor Stabilization and Crest Concrete Resurfacing


The Middlesex Hydroelectric Dam is located on the Winooski River in Middlesex. Vermont, about one mile upstream from the river's confluence with the Mad River. This concrete dam measures 283 feet long and 50 feet high, with two low-level sluice gates and two nine-foot-diameter penstocks that feed the powerhouse. The powerhouse contains two identical Francis Units that operate with a maximum capacity of 515 cubic feet per second and a total install generation of 3.2 megawatts. This project included the installation of 19 separate vertical rock anchors along the crest of the dam, resurfacing of the concrete along the crest, and an additional 2,000 square feet of concrete replacement along the downstream face of the dam. PC completed



the rock anchor placement and concrete work of the project on time and budget in October 2020. Due to mild weather conditions, the team was able to extend work on site an additional month through November 2020, completing needed downstream concrete resurfacing work that would have otherwise taken place in the spring of 2021. Through careful planning and coordination, the dam's operations remained uninterrupted throughout the duration of construction and the team maintained strict adherence to all water quality standards and requirements. PC successfully completed 13,100 worker hours without incident or recordable injury for this extremely high-risk work.


















ASCE Legislature Fly-In

On March 2nd and 3rd, Jessica Louisos, PE and Stephanie Wyman, PE attended the Annual ASCE Legislative Fly-In. Due to the Capitol building being closed to visitors due to COVID-19 restrictions, the meetings were held virtually. On Wednesday and Thursday they attended a keynote address by Dr. Geraldine Richmond, the Undersecretary for Science and Energy, U.S. Department of Energy and multiple issue briefings discussing the Infrastructure and Investment Jobs Act Implementation, Gas Prices Relief Act, Research and Development, Resilient Infrastructure, and Water Resources Development Act. On Thursday afternoon they attended meetings with the offices of Senator Patrick Leahy, Senator Bernie Sanders, and Representative Peter Welch to discuss these topics and the importance of supporting the funding of Vermont's infrastructure. They also extended their gratitude on behalf of ASCE for their vote supporting the IIJA last fall. The offices were very appreciative for our time to discuss these topics with them and said that they rely heavily on our ASCE Report Card to help highlight the state of infrastructure in Vermont. 
Engineer's Week Banquet - February 25th

New "Energy Goals" Requirement

In 2020, the General Assembly passed Act 178, which requires certain professionals licensed by OPR to complete an education module related to the State's energy goals as a condition of license renewal. See Act 178 (2020), Sec. 33. This requirement takes effect on July 1, 2021. [1]



The law applies to: (1) architects, (2) landscape architects, (3) pollution abatement facility operators, (4) water system designers, (5) professional engineers, (6) property inspectors, (7) real estate appraisers, and (8) real estate brokers and salespersons. The law also applies to some Vermonters licensed by other State agencies, such as the Department of Public Safety.

What is Required?

To help you meet the new requirement, OPR has partnered with other agencies to produce a PowerPoint that offers a concise, general orientation to the State's energy goals. These goals are derived from specific acts of the General Assembly.

You can view the orientation module here. Doing so now will save you time when you renew.

At the first upcoming renewal, the application form will require that you affirm having completed the orientation module linked above. It cannot be counted toward continuing education or competency requirements.

At each biennial renewal after the next, the law will require that you affirm having completed an education module specific to your profession's role in meeting the State's energy goals. By that time, environmental groups, state agencies, professional associations, and purveyors of green-energy products and services, will very likely offer a menu of free or low-cost options that satisfy the new requirement. Many of these will be eligible for continuing education credit in fields that require CE.

Please contact OPR if you have questions regarding this requirement.

[1] Pollution abatement facility operators: Although your renewal period opened in June, the effective date of your renewed license will be after July 1, 2021. Consequently, the new requirement applies to your current renewal.
