The candidate must be a registered professional engineer, a member of the WV Section ASCE, and a citizen of the United States. The nominator should be a registered professional engineer and endorsement(s) should be included from additional distinguished engineers who are ASCE members familiar with this individual and his/her accomplishments.

Qualifications of the award nominees will be judged on the following:

- X Sustained outstanding civil engineering performance
- X Evidence of high character and professional integrity
- X Civic and humanitarian activities (community service)
- X A minimum of 15 years service as a civil engineer
- X Five of the 15 years at the senior administrative level
- X Letters of Endorsement to substantiate the application information

A separate statement of 200 words or less (1 page double-spaced) should support the candidate's nomination. Facts presented should include engineering achievements in design, research, development, or management. Biographical information, citations of merit, and other accomplishments worthy of consideration should be included. The scale below will be used as guides to assist the selection committee. The selection committee's final decision will take into account the overall background and accomplishments of each nomination.

Please note the WV Section Awards committee may not present an award each year if there are no nominations or qualified applications presented for consideration (typically a minimum score of 75 is required for consideration).
