

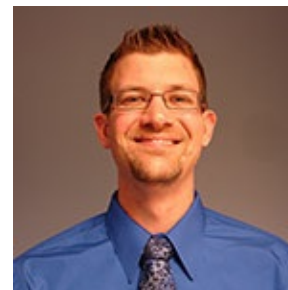

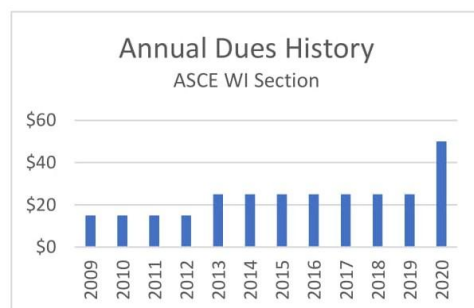

ASCE WI Section Board Votes To Increase Dues

The board believes ASCE and the Wisconsin Section provide tremendous value for our

members. Nationally, members can take advantage of 10 free PDH credits each year, along with numerous special topic meetings and conferences. The Wisconsin Section produces two general meetings each year, the Annual Meeting each fall and the Spring Technical Conference. Both of these meetings provide members

with PDH credit opportunities, networking opportunities, and celebrations for our colleagues' achievements. A large portion of the Section budget is allocated to Branches to assist with their programs and activities, such as golf tournaments that provide funding for local scholarships, events that promote educational STEM opportunities in Wisconsin's middle schools, local networking functions, and a multitude of other activities organized by the Younger Member Groups (YMG's). A small portion of the Section budget is allocated to awards, scholarships, and travel assistance for conferences.

An additional expense born by the Section is for association management, Impact Services. The Section is in the second year of working with Impact Services, which has brought continuity and efficiency to Section with communications, Annual Meeting logistics, Spring Technical Conference logistics, smarter & consistent social media and other board activities. This contract has lighted the efforts of the Section board so that the board can focus on more strategic issues. This includes taking advantage of more resources/opportunities that ASCE "National" provides. Impact Services is an annual expense of the section.

From State of the Union to ASCE Fly-In

On Tuesday, February 5th, I listened carefully to the State of the Union address, as well as the Democratic rebuttal. The President mentioned infrastructure only briefly unless you include the building of a border wall as a part of infrastructure. A border wall is infrastructure; however, it is only a very small part of infrastructure and one that does not contribute directly to the economic efficiency of the nation as do dams, roads, bridges, airports, water and sewer works, etc. I honestly hoped and expected more of a push for a major infrastructure package, but I was disappointed that I did not hear more about that in the president's address. Stacy Abrams of Georgia delivered the Democratic response in which she said the word transportation only once. She did not mention infrastructure. How do we fight for infrastructure improvements? I think it all falls under communication, but let's call it communications and lobbying or advocacy. Our best communication tool both nationally and locally is the ASCE infrastructure report card. For this reason your Wisconsin section is committing significant resources to creating a new infrastructure report card in the next year. Many of you will be called upon to get involved with this significant work.

UW-Madison Chapter Update

Student teams from the UW-Madison Chapter of Engineers Without Borders-USA and mentors from the Madison Area Professional Chapter traveled to Puerto Rico and Uganda in January 2019 for program assessment and implementation. In Puerto Rico, the students and mentors conducted their first assessment of the children's shelter where they will install a solar photovoltaic power system. They held meetings with the shelter, suppliers, and engineers to plan the system. The Uganda team signed land agreements for the tank and pump house of their water supply system and began construction on the pump house.

The Ecuador and Guatemala programs are continuing design work and fundraising for their projects: a community water system and pedestrian bridge in Ecuador and a 20km long water pipeline in Guatemala. Both groups plan to travel in the summer of 2019 for implementation.

PE License Rule Changed

What just happened regarding PE licensure in Wisconsin? On January 1, 2019, the administrative rule A-E 13.06 (2) was repealed. That was the effective date of the repeal in the administrative code. My investigation revealed the process and steps that led to this. One could say it was a done deal long before this recent effective date. What was repealed? A-E

13.06 (2) was a provision authorizing the licensing board to perform random audits of licensed professional engineers continuing education credits. The same authorization of random audits was repealed for architects, landscape architects, and land surveyors in their respective rule sections.

Back on June 7, 2018, the Joint Committee for Review of Rules approved a petition from the examining board and ordered the repeal of the provisions. The Joint Committee is a committee of the State legislature. The petition had been filed with the committee back on April 25, 2018 using the expedited process of state statutes S.227.26 (4). The expedited process is only used for repeals of current rule provisions.

Why did the chair request the repeal? The chair requested the repeal because the execution of random audits was no longer authorized because of a provision in the 2017 State budget bill from September 22, 2017.

Civil Engineers Urge Congress to Pass Infrastructure Bill in 2019 after President Trump's State of Union Address

The following is a statement by Robin A. Kemper, PE, President, American Society of Civil Engineers (ASCE) on President Trump's State of the Union address to Congress on February 5, 2019:

“We appreciate that the President identified infrastructure as one of his top priorities for legislative action this year, and indicated that it is not an option, but a necessity. Infrastructure plays a vital role in the safety and well-being of every American, and ASCE's 2017 Infrastructure Report Card gave the nation a dismal D+ across sixteen categories.”

“It is no surprise that 79 percent of Americans say it is extremely important to increase spending on our nation's infrastructure. Infrastructure legislation must be at the top of the list for the 116th Congress. The American people are counting on them to work together to identify funding to modernize America's infrastructure.

ASCE believes that a bipartisan infrastructure bill should address the following priorities:

- Fix the Highway Trust Fund to modernize our nation's roads, bridges and transit systems.
- Eliminate the cap on the Passenger Facility Charge to modernize our nation's airports.
- Put trust in the Harbor Maintenance Trust fund by fully appropriating the Harbor Maintenance Tax collections each year.
